Practice Overview

Laura is recognised by the Legal 500 as a “Leading Junior” in the field of Court of Protection. She regularly appears in the jurisdiction dealing with s.21A challenges and s.16 welfare applications. Court of Protection

Education Law

Laura is joint head of the Education Team at 30 Park Place. Since joining chambers, she has developed a flourishing practice in the Education Tribunal for Wales and Health, Education and Social Care Chamber in England. Laura appears on behalf of local authorities and responsible bodies in appeals against IDPs and disability discrimination claims. Laura is happy to receive instructions from parents and learners.

Administrative Law

Laura often advises at the pre-issue stage, which can sometimes lead to settlement.
