### Practice Overview

---

A middle aged man suffered severe head injuries in a motor cycle accident. Case settled in 2013 for £3.3 million.

- Re F – A

Man injured in a road traffic accident when riding his motorcycle. He was rendered a paraplegic. Case settled in 2014 for £2.6 million gross.

- Re G

A young man in a road traffic accident who suffered disabling head injuries. He lacked capacity. Case settled in 2012 for £2 million gross

- Re W.L

A young woman in a road traffic accident left with a high level C5/6 spinal injury. Case settled in 2014 for £8.2 million on a provisional basis.

## Personal Injury & Clinical Negligence

This work forms the bulk of Lloyd's practice. Most cases are high value brain and spinal injuries. In many cases he acts for protected persons. They involve dealing with badly injured litigants, their families, numerous medical and other experts, deputies and the Court of Protection.

## Regulatory & Inquests

His regulatory work involves HSE cases in the criminal courts encompassing manslaughter and breach of regulations. He has appeared in many inquests, including death in custody and the Corus steel works explosion.

## Police Actions & Prison Law
