Rhys Taylor specialises in money and property disputes following family relationship breakdown.

Judgment involving a careful application of constructive trust and proprietary estoppel doctrines which determines that a cohabitant had no equitable interest in a farm property in which she had lived and in respect of which she had made contributions.

In the field of financial remedy work Rhys deals with complex assets, often held by third parties, discretionary family trusts or companies.
